#### Next Stop is Trial for Kessler Topaz as Lead Counsel in Investor Class Action Against Walgreens

An Illinois federal judge on Tuesday pared back class claims brought by Walgreens investors claiming the pharmacy retail chain and two former executives inflated its earning goal, partially granting summary judgment in the company's favor while finding that a number of claims belong before a jury.

U.S. District Judge Sharon Johnson Coleman granted in part and denied in part a summary judgment motion from Walgreen Co., former CEO Gregory D. Wasson and former Chief Financial Officer Wade Miquelon. The judge also denied a partial summary judgment motion from the certified class of investors, who allege the company made misleading statements surrounding an earnings goal for fiscal year 2016. **Read Law 360 Here** 


