

ZILLOW BRINGS GOLDMAN FIGHT TO SKEPTICAL 9TH CIRC.



The Ninth Circuit on Thursday cast doubt on Zillow Group Inc.'s efforts to decertify an investor class claiming that the real estate listing site oversold

a now-shuttered home-buying program, appearing skeptical of arguments that a recent U.S. Supreme Court decision worked in the company's favor.

A three-judge panel sitting in Alaska heard oral arguments in the appeal, which will be the first in the Ninth Circuit to interpret the Supreme Court's 2021 ruling in *Arkansas Teacher Retirement System v. Goldman Sachs Group Inc.*

In that case, the justices ruled that a company accused of securities fraud can overcome class certification if it can prove that its supposedly fraudulent statements were too generic to have impacted the price of its stock.

CVS CAN'T ARBITRATE RICO SUIT OVER ALLEGED 'NO GENERIC' POLICY



CVS effectively forfeited its arbitration rights in proposed class action litigation accusing it of conspiring to block Medicare beneficiaries from accessing

generic versions of prescription drugs, a Pennsylvania federal judge ruled in denying the company's bid to enforce an arbitration agreement.

CVS Health, along with its subsidiary retail pharmacy chain and pharmacy benefits manager, knew arbitration was potentially available but waited to pursue arbitration against one the plaintiffs until after the court had denied the company's attempt to toss civil racketeering claims, U.S. District Judge John Milton Younge said in a Tuesday memorandum. By doing so, Judge Younge ruled, CVS waived its arbitration rights in the litigation.
